

# General Contest Information

## Contest Categories

The contest will have four categories. You will be judged on: -  
Interview

- Bar Wear

- “Pecs and Personality”

- Full Leather (leather attitude) with a 90 second speech

**Interview-** The interview is held privately, Saturday afternoon. This category has the highest scoring value in the contest. Questions will be asked so the judges get to know your personality, experience, communication skills and goals.

**Bar Wear-** This is the contestant’s introduction to the audience. Initial dress is the contestant wearing an outfit they would wear to look good in when going out to the bar or event. This casual dress must include leather.

**Pecs & Personality-** Each contestant will have an opportunity to show off their “best assets”. Make it original and fun. Express your individuality. No nudity! Remember, this is a public event.

**Full Leather/Speech-** This can include, but is not limited to, full leather uniform, chaps, codpiece and vest, etc. Each contestant will be judged on his overall appearance in leather on stage. The subject for your 90 second speech is completely up to you. Judges will be looking to see how composed you are and how well you can articulate your thoughts in front of a crowd.

## **Qualification Requirements**

All contestants must have a valid 2009 Campit Membership (\$10).

All contestants must be 21 years old with appropriate picture ID.

## **Contestant Responsibilities**

Contestants are responsible for their own lodging, food and attire for the contest.

The winner's responsibility is to represent Campit Outdoor Resort and the Mr. Campit Leather Title in a positive way and act as a leader to build and strengthen the leather/kink community.

The winning titleholder is required to participate in all of:
